The Constitution Party was organized in 1992 under the name of the U.S. Taxpayers Party. It's primary Founder was Howard Phillips (1940-2013), a former cabinet-level member of the Nixon administration and founder of the Conservative Caucus.

In 1999, the name was changed to the Constitution Party in order to better reflect its primary mission.

THREE PILLARS

Life and the Constitution Party

Human Life is sacred. The Constitution and the government it created exist solely to protect all our natural born rights, including the right to Life.

The Constitution Party is 100% committed to protect Human Life from conception until natural death.

Liberty and the Constitution Party

All people are born with a God-given natural right to be free in their thoughts and choices, and to experience the natural consequences be they good or bad.

The Constitution and the government it created exist to protect our rights; it does not give or take away rights unless the rights of others are violated as prescribed by law.

The Constitution Party is committed to providing candidates which understand the source of rights and who are committed to protecting Liberty at all times.

Integrity and the Constitution Party

Without integrity in our personal lives and our public lives, there is no Liberty.

Leadership without Integrity cannot safeguard the principles of Liberty.

The Constitution Party is committed to providing candidates with Integrity, or we will withdraw our support.

SEVEN PRINCIPLES

SANCITY OF LIFE: The Constitution Party is 100% committed to protect Human Life from conception until natural death.

NATURAL FAMILY: The Natural Family consisting of parents, children and extended family members is the social and economic foundation of any successful society. The Constitution Party is committed to protecting the Natural Family.

PRIVATE PROPERTY: Private Property and Personal Security are essential to Liberty and the sustaining of Life. The Constitution Party is committed to protecting the individual right to own and control private property.

POWER OF THE STATES: The states created the federal government, ceding specific and defined powers to it. The Constitution Party supports the power of the states to nullify any congressional or executive actions which exceed or ignore those limits.

THE FOUNDING DOCUMENTS: The Constitution Party doctrine is founded upon the principles of America's Founding Documents, i.e., the Declaration of Independence, The Constitution, and the Bill of Rights. **ALL** congressional, executive, or judicial actions which exceed or ignore those principles are null and void.

LIBERTY: Natural Liberty is the power of acting according to one's own will or conscience, restrained only by the laws of nature and civil governments. The Constitution Party is committed to protecting the Natural Liberty of the people and opposes any governmental action that would deprive persons of life, liberty or property without due process of law.

AMERICAN SOVEREIGNTY: The United States is properly a free and sovereign republic which should strive to live in peace with all nations,

without interfering in their internal affairs, and without permitting their interference in ours.

TWELVE ISSUES

Religious Freedom: The Constitution Party calls upon all branches of government to cease their attacks on the religious liberties of the people and the states, regardless of the forum in which these liberties are exercised.

Education: The States did not give the federal government power over education; therefore, all educational agencies, funding, and regulations must be nullified by the states. The parents have primary responsibility for the education of their children.

Gun Control: The right to bear arms is inherent in the right of self-defense, defense of the family, and defense against tyranny, conferred on the individual and the community by our Creator to safeguard life, liberty, and property, as well as to help preserve the independence of the nation.

Veterans: The Constitution Party appreciates the contributions of our servicemen and veterans to the preservation of American freedom. We shall continue to recognize their contributions to the national welfare by providing equitable pay and benefits to our military personnel and generous health, education, and other benefits to veterans.

Foreign Policy: The United States is properly a free and sovereign republic which should strive to live in peace with all nations, without interfering in their internal affairs, and without permitting their interference in ours.

Immigration: The Constitution Party affirms the integrity of the international borders of the United States and the Constitutional

authority and duty of both the states and the federal government to secure their borders against foreign invasion.

Tariffs and Trade: Congress may not abdicate or transfer to others these Constitutional powers, including the President of the United States. The Constitution Party opposes the unconstitutional transfer of authority over U.S. trade policy from Congress to agencies, domestic or foreign, which improperly exercise policy-setting functions with respect to U.S. trade policy.

Drug Abuse: The Constitution Party upholds the right of states and localities to restrict access to drugs and to enforce such restrictions. Violations of the constitutional and civil rights of American citizens must be prevented. Searches without probable cause and seizures without due process must be prohibited. The presumption of innocence must be preserved.

Judiciary: The Constitution Party supports Congressional enforcement of the Constitutional rule of good behavior and to restrain judicial activism by properly removing offending judges through the process of impeachment provided for in Article I, Sections 2 and 3 of the Constitution.

Terrorism and Personal Liberty: America is engaged in an undeclared war with an ill-defined enemy (terrorism), a war that threatens to be never-ending and that is being used to vastly expand government power, particularly that of the executive branch, at the expense of the individual liberties of the American people. The ‘war on terrorism’ is not a proper excuse for perpetual U.S. occupation of foreign lands, military assaults on countries that have not injured us, or perpetual commitment of taxpayer dollars to finance foreign governments.

Healthcare and Government: The Constitution Party opposes the governmentalization and bureaucratization of American medicine. The

States gave no constitutional authority to the federal government to control healthcare at any level.

Social Security: Social Security is a form of individual welfare not authorized in the Constitution and should be repealed. The Constitution Party advocates PHASING OUT the entire Social Security program, while continuing to meet the obligations already incurred under the system, limited to the total contribution of each individual.
